A special meeting of the Mayor and Council of the City of Atkinson, Nebraska, was held in the Council Chambers of the Municipal Building at 104 S. Main Street, Atkinson, Nebraska on the 26th day of February, 2025 at 5:15 o'clock p.m. The meeting was called to order by Mayor Erickson.
