Council Proceedings April 7, 2025

A regular meeting of the Mayor and Council of the City of Atkinson, Nebraska, was held in the Council Chambers of the Municipal Building at 104 S. Main Street, Atkinson, Nebraska on the 7th day of April, 2025 at 7:30 o'clock p.m. The meeting was called to order by Mayor Erickson. On roll call the following were present: Chuck Asher, Ron Krysl, Helen Olson, Leo Seger, Scott Shane. City Attorney, Michael Sholes and City Clerk, Shelly Wieneke. Absent: Jerry Osborne

Notice of the meeting was given in advance by publication in the Atkinson Graphic, Atkinson, Nebraska as shown by the affidavit of publication. Notice of the meeting was simultaneously given to the Mayor and all members of the City Council and a copy of their acknowledgement of receipt of notice and the agenda is attached to these minutes. Availability of the agenda was communicated in the advance notice and in the notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Mayor Erickson publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated that the poster was on display on the east wall.

Moved by Olson, seconded by Seger to approve the minutes of the March 3rd meeting. RCV: Ayes: Asher, Krysl, Olson, Seger, Shane. Nay: None. Absent and not voting: Osborne. Motion Carried.

Treasurer's Report for March was discussed and placed on file.

The council acknowledged receipt of the March minutes of the Library, Elkhorn Meadows, HCED, Airport and the Union Street Duplex Financial Report.

Moved by Seger, seconded by Asher to approve releasing the city's subordinate lien on Hoskinson LLC to Nebraska Bank. The city would then assume second position on the lien. As reported by Cheye Young, Economic Development Director, Hoskinson has refinanced their loan with Nebraska Bank and the City usually has second position on the lien for LB840 loans. Bev McConnell was present to discuss Hay Days which will be held August 15th, 16th, and 17th. The Coronation Dance will once again be held downtown on Friday, August 15th and the Ranch Rodeo will be held on Friday, August 15th and Saturday, August 16th. Bev asked the council if they would consider no parking on both sides of the street along the parade route so that the bigger equipment that is in the parade is able to easily maneuver. Further discussion on this will be needed as they do not want to discourage the people who are unable to walk a distance to the downtown area to see the parade from attending. Certificates of Insurance will be brought to the city office for events that are being held on city owned property.

The Grasshopper mower is remaining for sale and the Hustler Fastrak sold almost immediately after listed. It was decided to drop the price of the Grasshopper from \$4,500.00 to \$3,500.00.

Discussion of a future duplex project for the City of Atkinson was discussed. Cheye Young, Economic Director, stated that land would have to be purchased and be shovel ready for

grants to be applied for. Cheye feels that there will be grants available soon to help assist in a project and that having our housing study done and a lot ready will be important. The council agreed that we should start the process of looking for a lot suitable for a project and once found start the process of purchasing the lot.

Discussion was held on the condition of North Main Street from Highway 20 to West Holt Schools. The street has been on the One- and Six-year Street Plan for several years now and Shelly Wieneke, City Clerk, asked the council if they were ready to proceed with the beginning stages of completing the project. This project would need to be bonded and will be a longer process to complete. The question was raised as to whether they wanted to add any other streets such as North Carberry from the Cowboy Trail to Highway 20. It was noted that Miller and Associates were just in town to look at a couple of other places in town that need repair. The council agreed that they would like to start the process of beginning the project.

Discussion of overtime for city employees was brought up. Ron Krysl stated that he had a couple of city utility employees approach him about when overtime was allowed. The council agreed that nothing had changed regarding overtime since the discussion was held with the maintenance department, in which Gary Thurlow, Utilities Supervisor, and Travis Schmitz, Utility Department Employee, were present for in January of 2022. Overtime is only allowed in emergency situations such as snow removal. If possible, time should try to be taken off within the same week so that overtime can be avoided. Overtime is only compensated at time and a half over 40 hours worked in a week, and unless an emergency comes up, it should be avoided.

Future topics for "Cops Corner" was brought up by Ron Krysl. He would like to see it continue, but to discuss topics of City and State law. Chuck Asher informed the council that this had been discussed with Jimmy Collins, Chief of Police, by members of the Personnel Committee and Mayor Erickson.
